COORDINATOR'S MESSAGE

Convention Plans

Program

I am delighted to announce that both SWAP's nominations for speakers were accepted for this year's CPA convention in St John's, Newfoundland, June 10-12.

Dr Carolyn Zerbe Enns will be a CPA Invited Speaker. Dr Enns, a professor at Cornell College in lowa, has published extensively in the area of feminist counselling and therapy. Her most recent work has been on feminist therapy in cross-cultural contexts. In her presentation, "Feminist Practice in the Twenty-first Century: Erasing Boundaries and Expanding Our Vision," she will propose themes for an inclusive feminist psychology that embraces diversity and is attentive to the multiple identities and social locations that influence human experience. SWAP is cosponsoring Dr Enns with the Counselling Psychology Section.

Dr Janet Stoppard will be the

SWAP Section Keynote Speaker. A professor of Psychology at University of New Brunswick, she is a well-known expert in the area of women and depression. In her talk, she will focus on how a social constructionist epistemology can inform our understanding of women's experience of depression.

Social Event

We are also planning to have a SWAP social event at the convention. One possibility would be to have something after our business meeting, which will probably be on Thursday, June 10. Another option would be to organize an evening event. There is, for instance, a boat tour which leaves from downtown St John's and winds along the coast to Cape Spear, the most easterly point in North America. On a beautiful evening, it is a spectacular trip. As someone who lived in St John's for seventeen vears. I know, however, that there are no quarantees about the weather, which is stunning in its unpredictability. I would like some input from members about what kind of event you would like to have.

Pre-convention Institute

SWAP is also sponsoring a preconference institute, "Women's Relationships with Their Bodies: Context and Culture," which will be held the day before the conference on Wednesday, June 9. The Institute will offer a mix of referreed papers, symposia, and workshops focusing on multiple aspects of women's relationships with their bodies, including disordered eating, sexuality, body image, aging, ability/disability, abuse, and body enhancing

surgery. There will also be an invited speaker, Dr Natalie Beausoleil, a professor in the Division of Community Health at Memorial University, who has been a vocal critic of our culture's narratives about body image. In her talk, For Health's Sake: Obesity Panic, Lifestyle Discourses, and Body Image," she will argue that the current focus on obesity as a lifestyle issue is feeding unhealthy obsessions with beauty and health while obscuring patriarchal, socio-cultural and political explanations for health problems.

We hope to see many of you at the Institute. The next issue of Psynopsis will have the registration information. If you have any questions about it, you can contact me or Karen Kranz.

Membership fees and benefits

We are currently conducting a review of our membership fees and benefits. As many of you know, SWAP has one of the highest membership fees among CPA sections. Our rationale for this has been that we offer more benefits to our members than many other sections, for example, we allocate \$1500 yearly for student support, with \$500 for the student paper award and \$1000 for five student travel bursaries. Recently, however, one student expressed a concern that the \$10 fee was too high for some students. Because we do not want financial concerns to preclude from anyone from joining SWAP, the Executive has decided to review our membership fees. Currently Lisa Craig, a graduate student at Mount St Vincent University, is examining what membership benefits are offered

by other CPA sections in order to see how we compare with other sections. This information will help us decide if we should adjust our membership fee structure. We will present a report about this at the Annual General Meeting.

Of course, we welcome your thoughts on this issue. Do you believe that SWAP's membership fees are too high or should we maintain the same fee structure? Do you have some other ideas about what our fees should be? For example, should we decrease our student fees and keep our regular member fees at the same level?

With the move to an email format for the newsletter, our expenses have decreased considerably. The Executive has been discussing ways to re-allocate this money. A SWAP social event is one proposal and reducing membership fees is another. Please contact me if you have any other ideas.

Finally, please give us your feedback about our new format for the newsletter.

The deadline for the chapter call listed below has been extended.

We have chapters representing Arab women from United Arab Emirates, African American women, Indian American women, Indian American women, Taiwanese women, Jewish women, Latina women, and South African women. Book Title: From Shame to Honor: Multicultural Feminist Journeys Editor: Thema Bryant-Davis, PhD Psychology of Women Book Series for the American Psychological Association

This book is needed due to the pervasiveness of factors that contribute to women,s shame, such as sexual violence, physical violence, trafficking, racism, poverty, ageism, beauty myths, and gender socialization by patriarchal community structures, governments, and media tools. It is important, however, to disclose not only the sources of shame for diverse women but also the sources of honor. This book will be important for women of different cultures who are trying to move from shame to honor as well as psychologists who work with women on pathways of healing from shame. This will be the first book to look at both shame and honor from a multicultural perspective and feminist perspective. In addition the multicultural perspective will not only include ethnically diverse women in the United States but also ethnically diverse women internationally. The contributed chapters will each focus on one U.S. based ethnic group or one international ethnic group. The contributing authors will be mental health professionals who actually are members of the group of women that they are writing about. Each chapter will address the following questions:

What are social, cultural, and psychological contributors to shame for the women you are writing about, including gender and ethnic oppression?

What are the effects of shame

in women,s life of your ethnicity how does it affect mental health, physical health, relationships, and academic and/or vocational pursuits?

What are the buffers that protect women of your ethnic group from shame?

What are the risk factors that leave women of your ethnic group more vulnerable to shame?

What are the social, cultural, and psychological contributors to honor within your cultural context?

What are the mental health benefits and behavioral correlates of honor for women of your cultural group?

What are positive or selfenhancing behaviors for which women are shamed in your culture ^ for example getting an education or leaving an abusive marriage?

What are characteristics or behaviors for which women in your culture are honored although the practices are in some way damaging to the woman?

What steps are important for women of your culture who are moving from shame to honor?

What should psychologists be aware of when conducting clinical work or research with women of this particular group around issues of shame and honor?

What are systemic, societal, institutional changes that would have to occur to reduce shame and increase honor in the lives of women of your culture?

The chapters should be between 20-25 pages, and must be grounded in theory and contemporary empirical research. Also be careful not to present members of your group as homogenous. Thank you for your interest in this important project.

FEMINIST REVIEW

Schissel, W. (Ed.) (2000).
Teaching and learning
liberation: Feminist pedagogies
– The 1993 conference
revisited. Women's Studies
Research Unit, University of
Saskatchewan, pp. 53.

This document is both innovative and interesting as a compilation of papers that focus on the interweaving of feminist teaching and research. It is a tribute to the accomplishments of the 1993 Feminist Pedagogies Conference organized by the Women's Studies Research Unit (WSRU) at the University of Saskatchewan. This document will also serve as an archive of feminist pedagogical research conducted by women at various teaching institutions across Canada, preserving our Canadian feminist psychological heritage.

This document is comprised of a foreword by the editor and four of the papers that were presented at the 1993 Feminist Pedagogies Conference. As noted by the editor, "[t]hough a small collection,

this is a powerful collection. Going back to these papers after several years, I can again hear the passion which provoked them. I've very glad that others will not have these documents to learn from, argue against, and make part of their archives of feminist pedagogical research" (p. 4).

Teaching and Learning Liberation: Feminist Pedagogies is formatted along the lines of a reader rather than an edited research volume. The simple, plain language used and the easy-to-read style draws the reader's attention to "hear" the uniqueness of each contributing author's "voice" in this collection. The first paper of this collection "Hearing the Voices in Our Classes" by Andrea Lebowitz appears as a personal narrative and poses the question as to whether or not feminist teachers have lost their connection with their students. A reflexive paper, it highlights some of the author's own university teaching experiences and provides quotes to highlight students' learning experiences. The reader is encouraged to consider four principles of feminist pedagogy that are proposed by the author.

These principles are: 1) meditation; 2) translation; 3) a voyage away from suspicion and isolation, and 4) comedy. This paper challenges the reader to incorporate these principles in the context of her own teaching experiences in order to better her student's learning experiences.

The second paper in this collection "Gender Bias in the Classroom: Elitism in Education" by Fran Davis and Arlene Steiger takes a more academic tone. It explores the process of how students internalize attitudes and

understandings of sexism transmitted to them through the teachings and practices of science in college classrooms. The authors provide the reader with insights into some of the impediments to feminist teaching, and the difficulties facing those who aspire to transform education to benefit women students in the scientific field. The work illuminates the challenges faced by feminist educators as they attempt to transform women students' attitudes and understandings of sexism in the classroom. This paper addresses gendered pedagogical issues and points the reader toward future directions in feminist teaching and research in post-secondary institutions, and provides a useful list of references for those interested in exploring these issues further.

The third paper in this collection "Gender Bias in the Classroom: Teaching Introductory Sociology 100 to 100 (Privileged) Students – The Sylvia Ashton-Warner Way" by Anne Louise Brookes strikes a balance in the use of a personal and an academic voice. It examines post-secondary students' notions of gender bias and suggests that feminist educators may apply the teachings of Sylvia Ashton-Warner as a way of clarifying and enhancing students' knowledge.

The many quotes by writers and scholars that appear throughout this piece make it particularly interesting and enriching to read, providing readers with insights into the meaning of conversation and education in the scope of feminist teaching. The reader is encouraged to empower students by employing feminist teaching methods, and by bringing to their

attention historical feminist perspectives on the construction of gender bias.

The fourth piece in this collection "Revising the Canon through Research and Pedagogy" by Uma Parameswaran is written in the first person perspective as a feminist educator and researcher. It introduces the idea of feminist research as comprised of three "R's": 1) Retrieving; 2) Recording, and 3) Re-reading. Expanding on this idea, the author invites the reader to consider the importance of each of these feminist research activities in general and specific to the teaching methods and research projects underway at the author's post-secondary institution. The reader is led to consider many issues in this piece such as the need to develop guidelines for conducting feminist research in university settings, the need to consider the universitycommunity connection in the research context, and the need to form research partnerships that reflect feminist values and tenets.

A lengthy and insightful paper, this piece helps the reader to bridge her understanding of feminist teaching and research and her awareness of some of the issues at the heart of this connection.

In summary, this document can be considered a feminist teaching tool as a collection of papers that seek to impart the spirit and wisdom of feminist educators and researchers across Canada. Teaching and Liberation: Feminist Learning Pedagogies archives the voices of contemporary feminist scholars and honours not only their voices but also the teachings of some of our foremothers. It compliments the archival video produced by WSRU of the conference proceedings, "A Better Tomorrow: Transforming the Classroom Through Feminist Pedagogy."

In addition to complimenting accomplishments of past WRSU conferences and archival works, compliments this document archival works forthcoming from the WSRU. One such accomplishment and archival work is an edited volume of papers presented at the 2001 WSRU Conference. This volume is currently in press as an anthology called "The Lived Environments of Girls and Women: Continuing Conversations" that is to appear in 2004.

SWAP Student Paper AWARD

In keeping with its goals of advancing the place of women in psychology and of promoting research of special relevance to women, the Section on Women and Psychology (SWAP) will offer a \$500.00 student paper award this year. To be eligible the paper must have been submitted to the 2004 Annual Convention of the Canadian Psychological Association or the SWAP preconference institute.

SWAP's mandate is: 1) to promote research, practice and education about and by women in psychology; 2) to make feminist research and practice visible within CPA and psychological communites more generally; 3) to 7

represent a collective of psychologists working to eliminate sexism, racism, classism, heterosexism and homophobia, ageism, and ableism. As such, the student paper award will be given to the paper that best represents any part of this mandate.

Submissions may be in French or English. Papers co-authored with a faculty member or non-faculty are acceptable, but the research must be primarily that of the applicant who must be first author. If a paper is co-authored by two students who wish to be considered together for the award (share the award if the paper wins), this must be clearly indicated on the submission and full information provided for both authors (see below).

Interested students should submit three (3) copies of a summary (approximately three (3) pages in length) of their paper or poster, with all identifying data (author's name and university) omitted from two of the copies of the summary. If any of the authors are not students, this should be indicated. Please include your mailing address (for late May 2004), Email address, phone number, your university affiliation, and a signed copy of the declaration provided below.

Submissions must be received <u>no</u> <u>later than May 7, 2004</u>. Selection will be by blind review. Selection criteria will include the following:

 Significant contribution to feminist psychology on any issue and/or a significant contribution to psychological knowledge about issues of particular

- concern to women and/or focus on activism or other applications of feminist theory/research.
- Diversity issues acknowledged/dealt with appropriately.
- 3. Methodological excellence either qualitative or quantitative.
- 4. Clear and effective writing style.

En accord avec ses objectifs reliés à l'avancement des femmes en psychologie, à la promotion de la recherche d'intérèt spécifique aux femmes, la section femmes et psychologie offrira un prix d'une valeur de \$500 pour le meilleur article écrit par un(e) étudiant(e). Le prix du meilleur article étudiant sera reservé à la communication livrée au colloque annuel 2004 de la Société canadienne de la psychologie qui a le mieux contribué à l'avancement de la connaissance psychologique sur un sujet qui a une importance particulière pour les femmes.

WOMEN'S WORLDS 2005 9th International Interdisciplinary Congress on Women Seoul, Korea

Date: from 19 June to 24 June 2005 Venue: Ewha Womans University in Seoul, Korea

The 9th International Interdisciplinary Congress on Women (WW05) is being organized by the Organizing Committee for WW05 in Seoul, Korea.

Korea, the first Asian country to host the 9th International Congress, offers a unique environment for exploring the ways in which fast-paced industrialization during the past decades has changed the lives of women and the manner in which women have mobilized development and globalization for their own national feminist causes. The distinct advancement of women's social and economic status and their quality of life, achieved in the midst of struggling with entrenched patriarchal and paternalistic values and the continuing tragedy of Korea as a divided people, inspired the theme for the WW05 Congress --"Embracing the Earth: East & West/ North & South." We would like to draw the attention of the international community, especially to the differences in the historical manifestation of patriarchal rule, given the evolution and cultural diversity of the Asian region.

Call for papers and proposals (deadline February 28, 2004)

We invite proposals on a broad range of material that constitutes the subject of Women's Studies. In keeping with the theme of the Congress, we welcome proposals that address coalition building, collaboration, and connectivity, particularly across barriers that have proved significant in feminism's past, such as those of race, ethnicity, nationality, class, age, sexual identity, and religion.

We also welcome proposals that investigate the application of Women's Studies beyond the classroom, such as internships, service learning, and community activism.

We encourage cross-cultural and interdisciplinary proposals as well as proposals from all fields in the humanities, the natural and social sciences, the creative and performing arts, health, law, social work, education, community development, and other professional and paraprofessional fields. The intention is to have a combination of both scholarly texts, as well as popular synopses of works by activists, advocates, and development practitioners from the fields of women's studies and gender studies.

Proposals may be submitted for individual papers, panels, workshops, round tables, short lectures, posters and presentations of creative works of art, film and writings.

- A panel would comprise three individual papers presenting theoretical issues or research data organized around a common theme pertaining to any field in Women's Studies.
- A workshop is an in-depth presentation designed to share

- skills, knowledge, and/or expertise in some areas of Women's Studies or feminist politics.
- In a roundtable, presenters (two or more) offer ideas and facilitate group discussion on problems of mutual concern, focusing on new ideas and problem solving.
- Posters, offering an alternative to presenting a full research paper, will be displayed during the entire conference. A special time will be scheduled to meet and talk to the presenters about their work.
- The artists', film, and writers' series will offer opportunities to present and receive feedback on an array of creative endeavors, including visual art, films, videos, prose, poetry, and/or non-fiction.
- Extras: Congress organizers will provide space for different organizations and interest groups to plan meetings and events that are relevant to the Congress. Those intending to do so should inform the Congress Secretariat before 31 December 2004.
- Pre-arranged panels and roundtables are encouraged to include presenters from different countries. Check our panel locater to find presenters interested in your topic. (coming soon)

Wednesday, 9 June 2004, St John's, Newfoundland Proposals are invited for the sixteenth Institute of the Section of

Women and Psychology (SWAP) of the Canadian Psychological Association (CPA).

This one-day Institute will be held on Wednesday, 9 June 2004, the day immediately preceding the CPA Annual Meeting which will be held 10-12 June, in St John's, Newfoundland.

The theme for the Institute is "Women's Relationships with Their Bodies: Power, Context. and Culture." Women's experience of their bodies is mediated by cultural and contextual pressures. The Western media's glorification of thinness, for instance, influences young women's eating patterns, body image, and self-images. The Institute will focus on multiple aspects of women's relationships with their bodies, including (but not limited to) disordered eating, sexuality, body image, aging, ability/disability, body enhancing

surgery, and body art (e.g., tattoos, piercings). The Institute is designed to bring together researchers and practitioners who offer a feminist lens on these and other issues related to women's relationships with their bodies. The format of presentations can be papers, symposia, panels, round-table discussions, or workshops.

<u>Guidelines for submission</u>
For all formats of presentations, please submit the following:

- 1. A cover sheet, listing the title of the presentation, the author's name(s), professional affiliation, address, phone number, fax, and email. For a symposium or panel, names of the moderator and/or discussants should also be included.
- 2. On separate page, a 200-300 word abstract/summary of the presentation with title. For symposia and panels, a separate abstract should be submitted for each presentation, as well as an abstract giving a general outline of the presentation. The abstract should include no identifying information.
- 3. Length of time needed for presentation. Single papers should not exceed 30 minutes. Symposia, workshops, and panel discussions should not exceed 1 hours.
- 4. Audiovisual requirements. All submissions will be blind reviewed. Please restrict any

identifying information to the cover sheet. Anyone may submit a proposal regardless of membership in SWAP or CPA. Submissions are welcome from people in disciplines other than psychology.

Deadline for submissions:

Proposals must be submitted via email and be received by Friday, 23 January 2004. Proposals sent in by other formats or after that date will not be considered. Travel Funds: SWAP provides travel funds to a limited number of students who present either at the SWAP Institute or the CPA convention.


