18TH SWAP INSTITUTE CALL FOR PAPERS

Advocacy, Activism and Policy Change: Is feminist psychology making a difference?

2007 Institute of the Section on Women and Psychology (SWAP)

Proposals are invited for the 18th Institute of the Section on Women and Psychology (SWAP) of the Canadian Psychological Association (CPA). This one-day Institute will be held on Wednesday, June 6, 2007, the day immediately preceding the CPA Annual Convention being held June 7 - 9 in Ottawa, Ontario.

The theme for the Institute is "Advocacy, Activism and Policy Change: Is feminist psychology making a difference?" This Institute is being held to examine the impacts that feminist research/practice/teaching has made on the psychological and social well-being of women, particularly with regard to policy and program change.

Workshops, symposia, panels, round-table discussions and individual papers on the following topics, from any discipline, are welcome:

- advocacy work and activism on behalf of women's psychological and social well-being;
- improvement in treatment, service or education protocols;
- development or change to mental health policies and practices;
- creation of education programs regarding the psychology of women;
- the creation of community-academic partnerships through research (e.g., participatory action research)
- recognition and advancement of women's human rights and psychology's role in addressing sexism, racism, classism, heterosexism, ageism and ableism.

Guidelines for Submission

Anyone may submit a proposal regardless of membership in SWAP or CPA and submissions are welcome from people in disciplines other than psychology. Proposals must be received via e-mail by Wednesday, February 28, 2007 and should include:

1. A cover sheet listing the title of the presentation, the author's name(s), professional affiliation, mailing address, phone number, fax and e-mail. For a symposium or panel, names of the moderator and/or discussant(s) should be included.
2. On a separate page, the title of the presentation and a 200-300 word abstract/summary. For symposia and panels, a separate abstract should be submitted for each presentation, as well as an abstract that provides a general outline of the presentation. The abstract should not include any information identifying the authors.
3. Length of time needed for the presentation. Single papers should not exceed 30 minutes. Workshops, symposia, panels and round-table discussions should not exceed 2 hours.
4. Audio-visual requirements.

Travel funds: SWAP provides travel funds to a limited number of students who present at either the SWAP Institute or the CPA convention (see pages 17 and 19).

FEMINIST MENTORING AWARD**

The purpose of the SWAP Mentoring Award is to recognize feminist supervisors who have promoted the advancement of their students through exceptional mentoring. Nominations are invited from students and recent graduates who wish to acknowledge a professor who promotes feminist scholarship, teaching, and practice and who has been pivotal to their graduate/post-graduate school experience. Nomination letters should describe how the mentor has been outstanding in supporting, encouraging and promoting your feminist research and facilitating your (as well as other students') professional, personal, and career development.

Nomination Criteria:

- Graduate and post-graduate students and recent graduates are invited to submit a nomination.
- Nominations should include:
 - 1) Cover page with students' and nominee's names, mailing and email addresses, phone numbers, university, department, and program of study.
 - 2) 1-2 page letter describing how the nominee's mentoring enhanced your graduate/post-graduate education and professional and personal development (e.g., helped develop your talents, facilitated joint and single authored publications, acted as a role model, etc). Explain your relationship with your nominee and how she/he has distinguished her/himself as a mentor for you. Feel free to share specific stories and anecdotes as appropriate. Nomination letters from multiple students is encouraged.

ON HER OWN: YOUNG WOMEN AND HOMELESSNESS IN CANADA

This research report addresses homelessness among young Canadian women. Glancing at the table of contents and flipping through the pages of this report, it appears to take a broad, comprehensive approach to this topic given the breadth of issues that are highlighted. However, upon close and careful reading of this report, it is evident that it is lacking in depth as few aspects of homelessness are discussed in detail. The report's lack of depth is its main limitation.

The research featured in this report was conducted to fulfill a critical gap in Canadian research on homelessness among young women. It is questionable whether it achieves this. Instead of focusing primarily on homeless young women, much of the report reviews literature and discusses youth homelessness from a gender-neutral perspective. While case study reports were conducted for eight cities based on interviews with more than 100 informants, these informants were persons working with homeless women and not homeless women themselves. As such, the information that was collected about local services and programs for homeless women may not reflect the actual perceptions and experiences of homeless young women. Case study research for only three cities – Vancouver, Montreal and Toronto – is presented while research for five other cities – Edmonton, Winnipeg, Halifax, St. John's and Yellowknife – appears in an appendix. Aside from this limited presentation of information, the report may be of interest to researchers, policy-makers and persons working with homeless young women.

This report is divided into six sections. Each section varies considerably in length. For the most part, each section is deficient in its organization and presentation of ideas. This ranges from the peculiar placement of critical information in some sections and not others, to the seemingly random appearance of tables. The lack of organization within and across sections makes it difficult to determine precisely what information is central to the authors' argument.

In the first section, *Introduction*, information pertaining to the research focus, objectives and methodology is presented. Literature on the usefulness and limitations of the case study approach is briefly reviewed. Terminology and definitions relevant to the study are also presented. A succinct overview of the research report appears at the end of this section.

In the second section, *Literature Review*, available literature on homeless young women is reviewed. The literature reviewed is intended to clarify relationships between factors that may put young women at risk for homelessness. Health-related problems of homeless young women are noted. This section concludes with a brief discussion of prevention and intervention strategies.

In the third section, *New Data on Young Women and Homelessness*, previously unpublished data on young homeless women in Montreal and Toronto is presented. This data pertains to demographics and shelter use. The authors argue that this data supports and expands previous findings. However, this argument is weak given the limitations of the data.

In the fourth section, *First-Tier Case Study Report*, the findings of the “first-tier” case study reports of homelessness in Vancouver, Montreal and Toronto are discussed. General characteristics of homeless persons in each region, changes in service users and services, and issue areas are identified. Quotes from informants emphasize a particular concern or issue.

In the fifth section, *Service, Program and Policy Review*, information regarding the service, program and policy context for Vancouver, Montreal and Toronto is given. Legislation along with policies and programs relevant to youth and homelessness are also presented. The manner in which the above cities are addressing homelessness is examined.

In the sixth section, *Recommendations*, service, program and policy recommendations for addressing homelessness in Vancouver, Montreal and Toronto are outlined. Program and policy recommendations for provincial and federal governments are proposed. Altogether, increased funding for prevention and intervention strategies targeted to at risk youth is recommended.

This research report is intended for an audience of researchers and policy-makers. While it might be of interest to those working with young homeless women, it offers little practical application. Programs, services, resources and references for homeless young women are lacking. Those seeking such information or resource material will need to look outside of this document. From an advocacy standpoint, providing a list of resources for homeless young women has potential to bolster prevention and intervention efforts in this area.

Returning to the main limitation of this report, lack of depth, details concerning the case study research are not provided, and this weakens the authors’ argument to increase funding for prevention and intervention strategies since the problem of homelessness among young women is not sufficiently illustrated with statistical information. The absence of details limits our understanding of how increasing funding for governmental programs may insulate young women who are at risk for homelessness. Researchers and policymakers may be disappointed at the paucity of statistical data and question how the case study findings for Vancouver, Montreal, and Toronto and subsequent recommendations may generalize to other Canadian cities.

As a whole, this research report fails to examine homelessness in sufficient depth and detail. This report, to a limited extent, increases our awareness of factors that may put young Canadian women at risk for homelessness. Clearly, more research in this area is needed. Future research using more rigorous methodology and samples of homeless young women from across Canada is likely to fill a critical gap in research and better inform our knowledge on this topic.

Significant theoretical, empirical, and clinical work recognizes the strong developmental and family context of dissociation. This issue of JTD will expand upon this literature to explore developmental patterns and family influences on normative and pathological dissociation across the lifespan. We expect the special issue will be simultaneously published as a book. We are seeking articles on topics including, but not limited to, the intergenerational transmission of trauma and dissociation, concordance for dissociation among family members, normative and problematic patterns of dissociation in childhood and adulthood, and issues related to the measurement and treatment of dissociation in understudied populations (e.g. young children and the elderly). Empirical papers and papers of clinical significance are encouraged, and will be peer-reviewed.

The Seventh Annual Geis Memorial Award for Dissertation Research offers \$15,000 for the 2006-2007 academic year to fund dissertation research in the Psychology of Women by an advanced doctoral candidate. Eligible research will demonstrate:

1. Grounding in contextual, social, and psychological models
2. Methodological soundness and sophistication
3. Contribution to the field of feminist psychology
4. Sophisticated research design in the social psychology tradition

History & Purpose of the Award

Florence L. Geis was a Social Psychologist with a strong commitment to research on the Psychology of Women and to the mentoring of women graduate students. In her will, she left an endowment to fund doctoral students conducting dissertation research in feminist psychology. To qualify for funding, the research must be 1) feminist, 2) address a feminist/womanist issue, 3) use social psychology research methods, and 4) make a significant contribution to social psychology theory and research. Proposals will be judged on suitability, feasibility, merit of the research, and the potential of the student to have a career as a feminist researcher in social psychology. Funding need not be used solely to fund the research project.

Who can apply?

Advanced doctoral graduate students in psychology or a closely related field whose dissertation research focuses on the psychology of women. The research must demonstrate:

Section on Women and Psychology (SWAP) STUDENT PAPER AWARD

In keeping with its goals of advancing the place of women in psychology and of promoting research of special relevance to women, the Section on Women and Psychology (SWAP) will offer a \$500.00 student paper award this year. To be eligible the paper must have been submitted to the 2007 Annual Convention of the Canadian Psychological Association.

SWAP's mandate is: 1) to promote research, practice and education about and by women in psychology; 2) to make feminist research and practice visible within CPA and psychological communities more generally; 3) to represent a collective of psychologists working to eliminate sexism, racism, classism, heterosexism and homophobia, ageism, and ableism. As such, the student paper award will be given to the paper that best represents any part of this mandate.

Submissions may be in French or English. Papers co-authored with a faculty member or non-faculty are acceptable, but the research must be primarily that of the applicant who must be first author. If a paper is co-authored by two students who wish to be considered together for the award (share the award if the paper wins), this must be clearly indicated on the submission and full information provided for both authors (see below).

Interested students should submit **three (3) copies of a summary** (approximately three (3) pages in length) of their paper or poster, with all identifying data (author's name and university) omitted from two of the copies of the summary. If any of the authors are not students, this should be indicated. **Please include your mailing address (for May 2007), E-mail address, phone number, your university affiliation, and a signed copy of the declaration provided below.** Submissions must be received by mail no later than Friday April 27, 2007. Selection will be made by masked review. Selection criteria will include the following:

1. Significant contribution to feminist psychology on any issue and/or a significant contribution to psychological knowledge about issues of particular concern to women and/or focus on activism or other applications of feminist theory/research.
2. Diversity issues acknowledged/dealt with appropriately.
3. Methodological excellence either qualitative or quantitative.
4. Clear and effective writing style.
