Thursday June 11 in Montreal. If the proposed definition is approved at this meeting, the definition will then be put forward to CPA for approval. This is a significant event in the history of Canadian Counselling Psychology. Come and have your voice heard.

I regret this message would not be complete unless I let my Pollyanna hat slip a little. Although I tend to see my glass as 3/4 full, it is impossible to ignore the state of the Canadian and world economies and the major impact this is having on individuals who have lost their jobs, businesses and institutions that have lost billions in investments, and governments that are going into deficit. Many of those who are employed are facing severe budget reductions, which are having an impact on the nature of their daily work experience. Locally, we hear that distress lines are busier than ever and I expect this phenomenon is touching other areas in Canada as well. The good news is that, as counselling psychologists, we are well equipped to assist during these troubled times; we have training and expertise in managing transitions and stress, coping skills, crisis management, and career development. This is a wonderful opportunity to consider how we, as individual psychologists, and we, as the Counselling Section of CPA, can embrace Principle IV of our Code of Ethics. We do have a responsibility to society! What are you able and willing to do? A few things jump to the forefront of my mind - offering pro bono services, volunteering at a distress centre, maintaining a positive attitude in your work environment, and advocating for mental health needs in a more systemic manner. Regarding this latter point, CPA has paved the way for us to provide information and feedback to the Canadian Mental Health Commission regarding their draft framework (see p. 3 of the latest edition of *Psynopsis*). We might also consider ways of becoming involved in the Commission's work related to stigma. currently have out Requests for Expression of Interest in anti-stigma projects. See:

This symposium will summarize the final report of the Executive Committee for a Canadian Understanding oof Counselling Psychology, formed in January 2007. The committee membership included members from different work settings, with various primary scopes of practice and different educational levels, and who

resided in a range of provinces and territories (including rural and urban settings). The committee membership also notably differed with respect to age. gender, socioeconomic status, sexual orientation, and ethnicity. The mandate of the Committee was to develop an understanding and definition of counselling psychology applicable to a Canadian context. The Committee conducted an exhaustive review of both academic and professional literature on the discipline of counselling psychology in Canada and also examined relevant international literature. Through critical analysis and discussion, the committee was able to define Canadian counselling psychology, outline its training, regulation, and practices, and compare and contrast it with counselling psychology in other countries and with other related disciplines.

Non-Suicidal Self-Injury (NSSI) is defined as the deliberate destruction of body tissue without suicidal intent which includes, but is not limited to, self-cutting, burning and hitting. NSSI has been receiving increasing attention in the last decade from media, researchers and mental health practitioners. Mental health practitioners in a variety of community settings are reporting increases in this behaviour. Few report having sufficient knowledge or training in this area. Newly emerging investigations into the prevalence, function, risk and protective factors for NSSI in community samples of youth and young adults report surprising results that mental health practitioners need to know. Based on this new information common myths about this growing problem will be challenged and implications for best practice will be explored.

Two Upcoming Changes to the Canadian Journal of Counselling

I haven't had the pleasure of meeting most of you, but I am Kevin Alderson, associate professor of counselling psychology at the University of Calgary. I would like all of you to be aware of two upcoming changes to the Canadian Journal of Counselling.

First, effective July 2009, the Canadian Journal of Counselling will begin to publish online short case summaries in a new section called "The Practitioners' Notebook." Further details are located in the *Call for Case Summaries* section below.

Second, effective July 1, 2009, CJC will be available online (http://cjc-rcc.ucalgary.ca/cjc/index.php/rcc). A hard copy of the journal will continue to be mailed to members of the Canadian Counselling Association and subscribers until October 2009, at which time hard copy will be discontinued. Beginning with volume 44 (January 2010), the journal will only be available online with members and subscribers having full access while other users will have access to all issues prior to the current year only.

Call for Case Summaries Introducing *The Practitioners' Notebook*

We invite ongoing submissions practitioners. Beginning July 2009, the Canadian Journal of Counselling will begin to publish online short (between 500 and 1000 words, not including a 50-100 word abstract) case summaries in a new section called "The Practitioners' Notebook." The notebook is intended to provide practitioners with practical and timely information about their successful work with a client. Although these summaries will not be peer reviewed, they are expected to contain two or three recent references that support the approach taken in working with the client. Furthermore, publication acceptance will remain with the editor of the journal, and successful submissions will be edited for content and/or grammar.

As part of your case summary, please include a Title (e.g., Counselling a High School Student with Severe Exam Anxiety) and the following headings:

- Relevant Background History (one or two paragraphs providing the most important background information regarding your client)
- Presenting Issues (list one to three primary issues affecting your client)
- 3. Theoretical Approach Utilized between one and ten words listing the theoretical approach behind your work with this client (e.g., solution-focused, narrative, person-centered)
- 4. Interventions (what did you actually do with the client?)
- 5. Outcome (what happened to the client? In what ways did she or he improve?)

Call for Nominations

Counselling Psychology Section: Distinguished Member Award

The Distinguished Member Award is intended to recognize someone who has made significant contributions to the field as a practitioner or as a researcher. We are looking forward to receiving nominations and presenting the award in Montreal.

In addition to being a member of the Counselling Psychology Section, the nomination criteria include:

Nominee will preferably have been active in the profession for at least 10 years.

Nominee has made a distinguished contribution in one or more of the following ways:

Outstanding counselling service.

- Scholarly research, which has moved the profession of counselling forward.
- Development of counselling materials which has contributed to the provision of service by others.
- Outstanding service to professional association, in particular to the C.P.A.

Counselling Psychology Section.

Other factors that will be considered are:

- Influence of the work to the profession of counseling (e.g., is the work moving the profession forward?).
- Breadth of influence (e.g., how many people have been touched/affected by the work?).

Documentation of these accomplishments can include:

Statement from the nominator providing rationale for nominating this individual.

- · Curriculum Vitae of the nominee.
- Sample of work, evaluation of work, letters from clients/colleagues, detailed descriptions of work, publication record, listing of positions held, and/or service contributions.
