2016 CPA Convention Preview

The Accreditation Panel is planning a number of activities for the benefit of training programs. First Street Accord Update

In 2012, the Canadian Psychological Association (CPA) and American Psychological Association (APA) through its Commission on Accreditation (CoA) approved and signed the First Street Accord. The Accord also indicated that effective Sept. 1, 2015, the APA would no longer accredit programmes in Canada, and the CPA would no longer accredit programmes in the USA. The CPA has developed a brief survey for Canadian Doctoral and Internship programmes to ascertain any impact these changes have had on their operations. Standards Revision

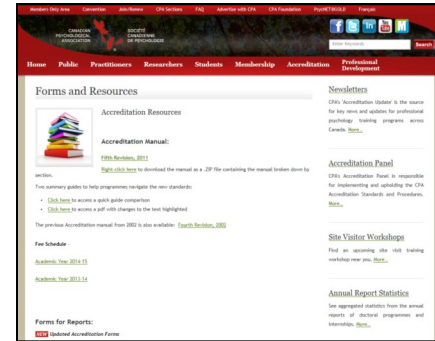
