This position is the Senior Psychologist in the Department of Family Services, Community Service Delivery Division. The position operates with a high degree of independence assuming responsibility for the planning, provision and assessment of psychological services on a department/division wide basis; developing and monitoring clinical policy and standards for behavioral/psychological services provided in the community and regions by the Department; providing clinical supervision and support for the Department's regional behavioral specialists/psychologists; developing and implementing a broad range of educational programs and services related to clinical applications for professionals and paraprofessionals; and providing clinically oriented consultation to both government and community.
