The Canadian Psychological Association's 72nd Annual Convention

TORONTO (June 2, 2011) - June 2nd through 4th, 2011 the Canadian Psychological Association (CPA) will host its 72nd Annual Convention in Toronto, Ontario, along with the 2nd North American Correctional and Criminal Justice Psychology Conference. The CPA Annual Convention attracts more than 2,000 researchers, practitioners and students who share the latest discoveries and developments about the science and practice of psychology.

Papers and presentations will cover areas of key interest to consumers of health care, educators, policy makers and the public at large. These will include topics such as bullying and violence among the youth, the stigma of mental disorders, traumatic stress, brain behaviour relationships, mental health issues in indigenous and north communities, mental health promotion in schools, attention deficit disorder, autism, and alcohol use and abuse.

Prominent speakers at this year's convention are:

Peter Graf, Ph.D. is the President of CPA and the chair of the Presidential Symposium and is known for his research in memory and will be speaking on "Prospective Memory Research and Findings: Faulty Brain; Flaky Person".

Susan T. Fiske, Ph.D. is Eugene Higgins Professor of Psychology, Princeton University. She investigates social cognition, especially cognitive stereotypes and emotional prejudices, at cultural, interpersonal, and neural levels – and author of over 200 publications.

John Gottman, Ph.D. is an emeritus professor of psychology at the University of Washington. He is world renowned for his work on marital stability and divorce prediction, involving the study of emotions, physiology, and communication.

Ed Diener, Ph.D. is giving the Science & Application Keynote Address on "New Scientific Findings on Subjective Well-Being". With over 30,000 citations to his credit, his research focuses on the measurement of well-being; temperament and personality influences on well-being; theories of well-being; income and well-being; and cultural influences on well-being.
