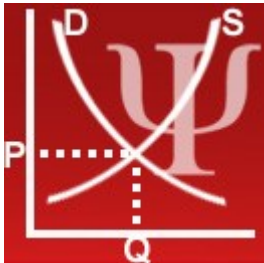
Psychological Practice and Usage of Progress Monitoring Measures".

Canadian Consortium for Research (CCR)

Dr. Votta-Bleeker continues to serve as Chair of the CCR. Although her 2-year term as Chair recently ended, Dr. Votta-Bleeker has agreed to stay on for an additional year.

The CCR is currently in the midst of preparing its submission

as part of the 2016 pre-budget consultation. Developing a science culture for Canada is the primary theme underlying the submission, which will focus on research funding, student scholarships/fellowships, and supporting/using research for policy-making.

The CCR is also developing a questionnaire as part of its election preparation, and already making plans to hold its 4th annual breakfast with the funders later this year.

CPA's 76th Annual Convention

The CPA's 76th Annual Convention was held in Ottawa (June 4-6), in conjunction with the 3rd North American Correctional and Criminal Justice Psychology Conference. Over 1,700 delegates attended the convention, which included 14 pre-convention workshops, 842 posters, and 204 presentations.

This year's convention also featured co-sponsored events with the Canadian Society for Brain, Behaviour and Cognitive Sci-

ence—namely a poster session, mixer event, and the CPA's Science and Applications Plenary speaker, Dr. Elizabeth Phelps.

In addition to connecting with friends and colleagues, the convention is an opportunity to honour the best in our discipline. Congratulations to this year's Award winners (Robert Hare, Stephen Porter, Debra Pepler, Ken Pope, Peter Suedfeld, Vivienne Rowan), Fellows (Tim Aubry, Jean-Paul Boudreau,

Officer of the Order of Canada: Dr. Kenneth Craig

The CPA extends its sincere congratulations to CPA Past President and Honorary Life Fellow, Dr. Ken Craig, for his recent appointment as an Officer of the Order of Canada.

Dr. Craig, Professor Emeritus at the UBC and Editor-in-Chief of *Pain Management and Research*, was recognized for providing a new model for the assessment of pain, and being a global leader

for research into the psychology of pain.

Dr. Craig was recently recognized as a founder of the CPA's Accreditation Panel (2014) and has received numerous CPA awards honoring his contributions to psychology as a science (2002), education and training (1996), and psychology as a profession (1991). He has been and continues to be a member of

various CPA committees, including the CPA's Scientific Affairs Committee.

Dr. Craig was one of 100 people named to the Order of Canada on July 1st. Dr. Craig will be invited to a ceremony to receive his award at Rideau Hall at a later date.

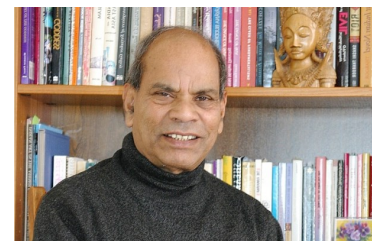
Dr. Das, Emeritus Director of the University of Alberta's JP Das Centre on Developmental and Learning Disabilities, is best was recognized for his work in

cognitive psychology, particularly for helping to develop a new theory of intelligence that proposed distinct parts of the brain determine a person's intellectual activity.

Dr. Das was also the recipient of the CPA's Award for Distinguished Contributions to the International Advancement of

Psychology at the CPA's 75th Annual Convention in Vancouver (June 2014).

Dr. Das was one of 100 people named to the Order of Canada; he will receive his award at Rideau Hall at a later date.

Advocacy for Psychological Science

Over the last months, the CPA has seized numerous opportunities to advocate on behalf of psychological science—in some cases, securing significant wins!

NSERC: CPA liaised with NSERC regarding eligibility criteria for students in clinical psychology which required them to have a supervisor who held an active discovery grant. In response to CPA's advocacy, NSERC removed this criterion. Provided the student's research fits the NSERC mandate, clinical psychology students can now apply for NSERC funding without corresponding requirements of their supervisor.

CIHR: CPA liaised with CIHR regarding caps on funding for equipment in its grant applications. In the midst of significant reforms to its open grant programs, CIHR has decided that there will not be any limits with respect to requests for proposed equipment

purchases in its open schemes (Foundation and Project).

SSHRC and NSERC: CPA met with representatives from SSHRC (Dr. Ted Hewitt, President) and NSERC (Dr. Pierre Charest, Vice-President Research Grants and Scholarship Directorate) to advocate for access to Centres of Excellence funds among all universities and researchers.

Government: CPA met with the Director of Policy for Minister of State for Science and Technology (MP Ed Holder) to discuss Canada's new science and technology strategy, particularly in response to the [submission](#) CPA made in February 2014.

Mitacs: The CPA continues to identify means of facilitating connections between psychology graduate students and Mitacs University Business Development Officers

so that students can pursue applications to Mitacs Accelerate program – internships involving industry-partners.
