Message sent to all of the Counselling Centre Directors and asked them to consider CPA accreditation.

Survey will be shut down Oct 1. 33% response rate; 74 full members of the section. About 1/3 declined the honorarium.

Section Chairs meeting. CPA is creating logos for each section. They are all similar except the name of the section. There is also a sections representative from CPA.

 Considerations for budget: Annual Convention reception has been significantly over for the last two years as has the executive dinner. 2015 budget to be considered in February meeting.

6. New Business

a. Conference Programming and deficits (e.g., Keynote, typical section stuff, symposia, LGBTQ, sponsor speaker with another section).

We will attempt to have poster session, AGM, keynote, and reception on Thursday. Ideas for keynote: Rob and Ada thought of themes of opening up to undergrads, speaker could be Jessica VanVleet; internationalization of Counselling Psychology, speaker could be visiting scholar at McGill from Taiwan. Discussion ensued. Rob to ask Ada regarding internationalization angle at our next meeting. Natalee suggested developing alternatives that go across years.

Idea of putting together symposia by connecting individual submissions. Natalee had a suggestion about how we might relatively easily connect individuals who might be interested in presenting together. This could be handled through a blog and let people put together their own symposia. Natalee will ask Lindsay to set up a blog for symposia interests.

Deficit in LGBTQ programming. Could advertise desire to have more LGBTQ, undergrad, and counselling psychology abroad programming.

- b. Nominate Fellows [Freda]. Freda suggested Jose Domene.
- c. Nominate members for Section/CPA Awards [Freda]. No names came up.
- d. CACUSS May 24th to 27th 2015 in Vancouver [Rob]. Do we want to go back to talk about accreditation? It is a good idea so we would need to consider someone close and who is involved in doctoral programs. It needs to be a marketing and PR person. Anusha is going to be chair of the internship committee. She would likely be a good person. Anusha will be invited.
- e. Award issues (thank you to unsuccessful, electronic posters, bachelor's posters) [Freda].

Current adjudication of electronic posters does not fit with our adjudication process. Freda will advertise that we will only adjudicate electronic posters that are a pdf of a regular poster and not slide presentations.

Discussion re challenges obtaining adjudicators.

We well send out an email to unsuccessful award applicants.

Question about bachelor's level posters – suggested letter of recognition. There are too few to make it competitive at this time. We will leave it be for now.

- g. *Survey of Student Members [Rob, Julie]. Rob is considering applying for ethics to expand survey to student members. Should be discussed more in the next meeting.
- h. *Fall newsletter [Rob] Blog. Need to replace Jose as manager of the blog. This should be a faculty member. Sharon could ask Vivian Lalande; Natalee could ask Richard. We will ask Vivian first and then ask Richard. If unsuccessful, we could put out a call and see if anyone is interested. In November Rob will be asking us to write up something about who the executive is and what they are doing.
