Dear Prime Minister,

On behalf of the Extended Healthcare Professionals Coalition (EHPC) – a coalition of 11 national professional health and social organizations – I want to acknowledge and commend your efforts to secure access for Canadians to COVID-19 vaccines approved by Health Canada. The addition of safe, effective vaccines to our suite of tools to combat COVID-19 marks a major scientific achievement and provides much-needed encouragement to the healthcare providers managing the pandemic in communities across Canada.

The EHPC is reassured by the federal government's progress to procure and expedite delivery of vaccines that have the approval of Health Canada and appreciates the collaboration between levels of government to ensure the rollout and distribution of the vaccine happens quickly and effectively. The EHPC agrees with the recommendations of the National Advisory Committee on Immunization (NACI) that priority access to the vaccine must be based on those at highest risk of severe illness or death due to COVID-19, those at greatest exposure risk due to maintaining the COVID-19 response, those contributing to the essential functioning of society and those at heightened risk of exposure due to living or working conditions.

As regulated health care providers who work in all across public and private sector – primary care, acute care, long-term care, home care and community-based settings – our members bring care to Canadians in their homes and communities. When our care is provided outside of Canada's publicly funded institutions, its coverage by extended health benefits plans reduces reliance on the publicly funded system for access to health care Canadians need. The need for many of these health care professionals to be in close, in-person contact with patients increases the exposure risk they face. To provide our members with the best means of protecting themselves and patients during the delivery of this care, the EHPC is encouraging governments to make the approved COVID-19 vaccines available to health care workers delivering care in all settings as early as possible in the vaccine roll-out. This will help ensure Canadians can continue to safely access the services they need to maintain their health so they can in turn support themselves, their families and the communities of which they are a part.

Again, we appreciate and value the tremendous efforts you have undertaken to secure access to and distribution of this critical measure in our collective response to the COVID-19 pandemic. EHPC members would be happy to consult with you on this matter further and welcome the opportunity to collaborate as you work across governments and organizations on the distribution and delivery of COVID-19 vaccines in Canada.
