I am looking forward to working with the Executive, and section members, over the next year, which I anticipate will be both busy and exciting. We have a number of tasks ahead of us this year.

We will be initiating a student recruitment drive in the fall. If you have students or interns who may be interested in joining the Section, please encourage them to do so.

We will also be active in the planning of the 1992 convention. Now is the time to submit suggestions to the Executive concerning invited speakers, preconvention workshops, and any special activities that would be of interest to clinical psychologists and CPA members. Deadlines for submissions of proposals from the Sections are fast approaching (despite the weather).

To help with advocacy, and to raise the profile of clinical psychologists, we will be preparing an information brochure that could be presented to interested nonpsychologists (e.g., patients, physicians, politicians, etc). In preparing this brochure we will consider the definition and scope of practise of clinical psychology.

We have also been approached to co-sponsor the annual Banff Conference on Behavioural Science. The executive will be considering these issues in our upcoming meetings, and your comments and suggestions on these issues are welcome.

In closing, I am looking forward to the next year and I encourage you to express your views to the Executive, and become involved in section activities.

#### **TRAUMA RESPONSE NETWORK**

Others may be conducting research on the effects of trauma or its treatment. These various activities are burgeoning across the country as the needs are becoming more widely recognised. But most of us know little of what the rest are doing and learning. Now is the time to establish a network of trauma workers so that we can exchange information about what we are doing, what knowledge we want or can provide, and who to turn to for advice or active assistance in an emergency.
