As past-chair of the Section, my role is primarily to answer questions posed by the current chair and chair-elect, to provide some continuity, background, and history. It has been a rewarding time on the executive over these past years. We hope you will enjoy the content of this year's convention.

Chair-Elect — Dr. Peggy O'Byrne, C. Psych



Alongside being Chair-Elect, I chair the leadership committee, which was initiated when the section began. From the start, there was a common interest to support and encourage leadership practices within the discipline of Psychology in hospital and health care settings. The aim of the committee has largely been two-fold. The first has been to encourage psychologists to consider the broad questions of leadership in their institutional practice, and to take up the challenge of promoting our discipline with the ultimate goal of improving patient care. The second aim has been to provide a forum of exchange, or a "think tank" for practice leaders, and those

interested in taking on such a role. In this latter objective we have sought to identify common themes, obstacles, challenges, and experiences that practice leaders grapple with in their institutional settings. We have begun to propose guidelines and activities to enhance our systems of communication, and to develop strategies to gather information on key issues. To this aim, we have initiated workshops and projects to promote and develop leadership capacity. Building from the pre-conference workshop at the last CPA convention, we are looking forward to the fruits of another workshop for practice leaders (and interested Psychologists) to be conducted at the upcoming conference in Victoria. The theme of this workshop will focus on psychology practice guidelines in health settings and we will consider how to implement national and local mentoring systems.

Secretary/Treasurer—Dr. Peter Henderson, C. Psych



As the Secretary/Treasurer of the Section I have been tasked with drafting the minutes from Executive's approximately monthly meetings through the academic year. These meetings provide an opportunity to plan the Section's contribution to the annual convention, review and develop content for the Newsletter and receive or provide updates on the activities of the various Section committees. The meetings have a formal agenda but there is much informal conversation which affords a pretty unique chance to compare notes on hospital psychology: the good, the bad and ominous developments from across the country. Taking minutes requires one to actually listen and summarize this

conversation and document any actions arising from the discussion. The Secretary, in essence, documents the history of the Section. One of the current questions is how best to share executive activities and minutes with the Section membership.

Financial matters constitute the other part of the Secretary/Treasurer role. Section fees provide income and the Treasurer monitors any credits and covers the Section expenses, chiefly from the convention, awards and projects. Each year CPA requires that Sections provide a financial accounting of the previous year and develop a budget for the next year based on convention planning and projects. As a non-profit organization, there is an expectation that the Section will not carry a large balance from year to year but rather use its resources to service the Section membership. Much of the Executive's time and energy is therefore devoted to discussion of how best to further the Section's purpose and objectives on behalf of the membership.

Member-At-Large — Dr. Theo DeGagne, R. Psych



My role as Member at Large for the past 2 years has been exciting indeed. It has been a privilege to work with such an energized diverse group of highly skilled individuals who bring with them the excitement of early career enthusiasm alongside seasoned mentors in the field. Last year, one of my roles on the committee was coordinating the CPA PHHC submissions for the Ottawa Conference. It was truly inspiring to receive so many innovative and excellent submissions that shared research, innovations in clinical practice, created round table discussions and symposia on topics that matter most to us. Poster presentations gave us

insight into how psychology is positively impacting everyday lives in public service sectors.

As a committee, we examined sectors of health care across the country and took stock on advocacy and accessibility issues; leadership roles, mentorship, development of hospital based guidelines, examined models of patient and client access to our services; we noted how innovation can impact the way we do business and why psychologists should be the identified leaders in technological advances in mental health and behavioral health care alongside the ongoing economic challenges we face working as public sector psychologists.

As we approach the 2016 CPA Convention I am again invigorated by the collaborative enthusiasm of this committee and insight into areas that matter for public sector psychology. As a relatively new section, this committee is rapidly evolving to represent and advance the efforts of psychologists in hospitals and health centers. In 2015 we hosted a pre-convention workshop entitled: "Leadership in Hospital Psychology: A call to Serve" which was attended by psychologists in leadership roles across Canada. This year we are hosting a special presentation on Innovations in Psychology Practice in the public Sector. My Colleague Dr. Christine Korol and I will be speaking in Victoria on Thursday June 9th at 2:15 on technology and innovations in psychology.
