Description of Vacant Executive Positions for 2009-10

Chair Elect

The term for the Chair Elect is one year, and this position then becomes Chair in year two and Past Chair in year three. There are several key duties associated with this position. First, the Chair Elect is responsible for organizing the Social and Personality Pre-conference. This involves selecting speakers, with an aim to balance Social and Personality talks, finding a location for the pre-conference, and arranging catering. The 2010 preconference will be held in Winnipeg, Manitoba in early June. Second, the major tasks of the Chair include lobbying for a Section invited speaker, invited symposia, and Section fellow, when appropriate. The Chair also acts as the Section program coordinator and attends a CPA business meeting the day prior to the Convention. This year there were 176 Social and Personality section submissions for the Annual Convention. Of these, 10 were declined based on feedback from our team of reviewers, for a 94.3% acceptance rate. Regret and Counterfactual Thinking: Bias vs. Benefit



Regret is a commonly felt negative emotion, and of interest to diverse fields in psychology. Regret may be defined in terms of its cognitive basis in counterfactual inference, meaning that regrets stems from the recognition that the past might have been better, had a different decision been made. Early research on regret emphasized its detrimental or biasing consequences for judgment and behavior. By contrast, a functional theoretical view places those drawbacks within the larger context of benefits for behavioral regulation and performance improvement. I will discuss recent research from my lab that illustrates the beneficial side of regret and counterfactual thinking.





Neal Roese is professor at the University of Illinois at Urbana-Champaign. He is an expert on judgment and decision making. Neal Roese is an Associate of the Center for Advanced Study at the University of Illinois, and is a Fellow of Association for Psychological Science. During his term as associate professor at Simon Fraser University he was awarded the first endowed Canada Research Chair in Social Psychology. His 2005 book "If Only" is about the psychology of regret and counterfactual thinking, and has appeared in four languages. His current research examines the intersection of reasoning, emotion, and mental health.




