Section Website

This website contains information about next year's preconference, section student awards, the section listserv, and the executive. This website is only in English. The CPA link for the section should be updated soon and this website will be searchable in search engines such as Google. The more you access it the easier it will be for others to find!

Section Finances

The section finances are The Social/Personality strona. section currently has 207 members (125 members and 82 student members). The section finances are fairly robust at the moment, with about \$3,500 in the bank account, plus more expected from preconference Approximately revenues. \$150-200 is being spent to host the section website and for associated costs, \$300 will be spent on student awards (see below), and \$800-2000 (depending on preconference be used for the size) will preconference. As well, \$300 provided may be as an honorarium for website maintenance. Thus, projected costs for this year are in the range of \$1250-2800.





Section Pre-conference 2007

Every year the Section has a preconference the day before the Annual CPA Meeting, usually at one of the local universities. The purpose of the preconference is to provide a more intimate opportunity for students, faculty, and other professionals to meet and present their research.

This past year the Section organized a preconference on June 6th, prior to the Annual Meeting in Ottawa. Nearly 70 people attended, with approximately two-thirds of those attending being students and one-third being faculty. For those of you weren't able to make it, the presenters and talk titles were:

Section Student Awards

Each year, the Social Personality section offers two awards to students presenting at the annual CPA conference. These awards, named to honour the memory of two Canadian social psychologists who made outstanding contributions to the field during their careers, recognize the best undergraduate (the Kenneth Dion Award) and the best graduate student (the Brendan Gail Rule Award) submissions. The SP section executives adjudicate the competition, selecting first and second place winners for each award. Each recipient receives a certificate to commemorate their receipt of the award. In addition, first place winners receive a \$100 prize and second place winners receive a \$50 prize. All students planning on attending the conference are invited to apply for the award. Undergraduates are especially encouraged to apply.

The application instructions for the Kenneth Dion Award and the Brendan Gail Rule Award are identical. What follows is applicable to both awards.

- Requirements: The student must be the first author on the project. Also, for the Kenneth Dion Award, the applicant must be an undergraduate student, and for the Brendan Gail Rule Award, the applicant must be a graduate student.
- Due date: It is usually the same due date as that for all abstracts for that year's CPA convention. However, this year it has been extended until November 30, 2007, because of the late announcement of these awards.
- To apply: Students who would like their work considered for an award must make a separate submission separate

from the CPA submission. This submission should include the following.

- 1. One copy of a cover letter written by the student indicating that they would like to be considered for either the Kenneth Dion Award or the Brendan Gail Rule Award (please specify).
- 2. Four copies of a 1000-word abstract, one with the authors' names included and three without, so blind reviews may be done. The following form should be used, including the headings:
 - Title
 - Author name(s) and institution(s) (one 1 of 4 copies only)
 - Area
 - Problem or major purpose. It is important that you provide adequate background information in the form of references and names of investigators or theories to help reviewers evaluate your abstract.
 - Procedure. State the rationale, design, controls, size and characteristics of the sample, and statistical tests employed.
 - Results
 - Conclusions and implications
- 3. One copy of a letter of recommendation from the student's supervisor.
