# Assistant, Associate or Full Professor (Teaching)

Faculty of Medicine – Department of Epidemiology, Biostatistics and Occupational Health, School of Population and Global Health

## **Position description**

The Department of Epidemiology, Biostatistics and Occupational Health, School of Population and Global Health, Faculty of Medicine, McGill University, invites applications for a full time or part-time faculty position at the rank of Assistant, Associate or Full Professor of Public and Population Health. This position is within the Contract Academic Staff and does not confer eligibility for tenure.

McGill University is one of Canada's leading universities, and the Department of Epidemiology, Biostatistics and Occupational Health is home to one of the largest concentrations of Faculty with expertise and interest in advanced epidemiological, biostatistical and public health methods for research and practice in Canada. The Department offers a vibrant academic environment and is one of the top units in its field in the world. The McGill School of Population and Global Health is developing its strategic plan for the next five years and the successful candidate will play an important role in the implementation and management of its public and population health academic programs.

## **Job Duties**

This is a teaching position. The successful candidate will spend at least 80% of time teaching and mentoring Masters of Science in Public Health (MScPH) graduate students. This will entail teaching 3 or 4 three-credit graduate courses per term for a full-time faculty member (up to 12 hours of weekly class time per term) and at least 2 three-credit courses per term for a part-time faculty member. We have particular needs for teaching in the following areas: public health management, systems thinking, implementation science, qualitative methods, health promotion, public health policies, aboriginal health, chronic diseases prevention, and mental health. Additional duties will involve contributing to various aspects of the management of the MScPH program. The successful candidate will have the potential to innovate in public and population health education as well as to develop meaningful and productive relationships with public health organizations to support and enhance public health training. The candidate will also demonstrate a strong commitment to equity, diversity, and inclusion in all areas.

## **Qualifications and Education Requirements**

Candidates must have a PhD or equivalent (MD with MSc for example) in public health or in a related field. Necessary qualifications for the position include in-depth understanding and experience working in the Canadian, Quebec or other relevant public health systems as well as understanding and experience of core public health activities (e.g. surveillance, prevention, health promotion and health protection). Degrees or studies in pedagogy or education would be important assets, though not required.
