

Psychologist - Ambulatory Child/Adolescent Mental Health

Psychology Department

Working as part of a team of clinical psychologists on the service, the Psychologist is responsible for providing a complete range of psychological services (i.e., diagnostic, assessment, psychotherapy, and consultation) to both outpatients in Children's Hospital, primarily as a member of our Child and Adolescent Mental Health Unit team. In addition to direct service, the Psychologist serves in research, educational, teaching, and supervisory roles within our Children's Hospital and our Psychology Department and maintains internal and external communication links with health care professionals in other agencies dealing with psychological programs and services. The successful candidate will also be a supervisor in the London Clinical Psychology Residency Consortium. Supervision is available for anyone requiring Supervised Practice as part of their registration with the College of Psychologists of Ontario.
